This Privacy Policy (hereinafter referred to as the "Policy") contains the procedure for processing and protecting of the personal data of Users which New Fashion Joint Stock Company, OGRN (Primary State Registration Number): 1027700429690, location address: 10, Presnenskaya Embankment, 123112 Moscow (hereinafter referred to as the "Company") may receive during the use by Users (including access, browsing and/or use of any interactive capabilities) of the maag-fashion.com Website and any other ways.

1. General

- 1.1. By using the maag-fashion.com Website, you agree that:
- a) You are a User and have read all terms and conditions of this Privacy Policy before using the New Fashion Website.
- b) If you started using the maag-fashion.com Website in any form, you accept all the terms and conditions of this Privacy Policy in full without any omissions and restrictions on your part.
- c) If you do not agree with the terms and conditions of this Privacy Policy, you shall immediately stop any use of the maag-fashion.com Website.

- d) The Privacy Policy (including any part hereof) may be amended by the Company without any special notice and without any compensation in connection with this. The new version of the Privacy Policy shall be effective from the date it is posted on the maag-fashion.com Website hosted on the domain at www.maag-fashion.com, unless otherwise provided by its new version.
- 1.2. By accepting the terms and conditions of this Policy, the User expresses his/her consent to processing of the User's personal data by the Company for the purposes of this Policy and transfer of the User's personal data to third parties in cases provided in this Policy.
- 1.3. As a general rule, the Company does not verify the accuracy of the personal data provided by the Users, however, the User hereby confirms the accuracy of personal data provided by him/her.
- 1.4. These terms and conditions govern the Company's relations with you and do not provide for governing third parties' rights.

2. Provision of Information by the Users

- 2.1 This Policy applies to the following types of personal data:
- 2.1.1. - 2.1.3. Pictures posted by the Users of the maag-fashion.com Website.
- 2.1.4. Other information about the Users posted or provided at their own initiative.

3. Purposes of User Data Processing

- 3.1. The Company collects and processes only the information on the Users, including their personal data required to perform the Company's obligations to provide the following information:
- For registration/authorisation of the User on the Website;
- Receiving news;
- Product information;
- Information on events or services, current contests, promotions:
- Informing the customer about promotions, discounts and special offers through electronic newsletters;
- Participation in surveys for marketing purposes, statistical and other research based on anonymised data;
- Process requests and applications.

3.2. If it is required to use the User's personal data for purposes not provided by this Policy, the Company requests the User's consent to such actions, and in some cases the Company acts under the legislation of the Russian Federation.

4. User Data Processing

- 4.1. The Users' personal data are stored in accordance with the applicable legislation of the Russian Federation.
- 4.2. The Users' personal data shall not be transferred to third parties, unless:
- 4.2.1. The User has expressly consented to such actions.
- 4.2.2. The transfer is required to ensure the operation of the Website.
- 4.2.3. The transfer is provided by the Russian legislation as part of a legal procedure.
- 4.2.4. To protect the rights and legitimate interests of the maag-fashion.com Website and/or third parties, where the User violates the terms and conditions of this Privacy Policy.
- 4.2.5. If the Company is involved in a merger, acquisition or any other disposal of any or all its assets. All obligations to comply with the terms and conditions of this Policy shall be transferred to the purchaser of the Company's assets.
- 4.3. The Company shall take the necessary and adequate technical and organisational measures to protect the User's personal data, ensure their proper use and prevent unauthorised and/or accidental access thereto.
- 4.4. When collecting personal data, including through the Internet information and telecommunications network, the data controller shall collect, record, systematise, accumulate, store, refine (update, amend), extract, use, transfer (distribute, provide, access), anonymise, block, delete, destroy personal data of citizens of the Russian Federation using databases located in the Russian Federation.

5. Rights and Obligations of the Parties

- 5.1. The User may:
- 5.1.1. Amend his/her data in the Account section of the maag-fashion.com Website.
- 5.1.3. Upon request, receive from the Company information on processing of his/her personal data.
- 5.1.4. Change his/her Personal Data, unsubscribe from email newsletters, revoke his/her consent to the Personal Data use.
- 5.1.5. The User's Personal Data shall be deleted from the Company's customer base within thirty (30) business days from the date of the relevant application.
- 5.2. The User's liabilities:
- 5.2.1. The User of the maag-fashion.com Website shall bear all risks related to the use and browsing of the maag-fashion.com Website. Neither the Company, nor any other person (being the representative or affiliated company thereof) involved in the design or operation of the maag-fashion.com Website shall be liable for direct or indirect actual damage and lost profit as a result of the use of the maag-fashion.com Website.

- 5.3.3. The Company reserves the right to amend or otherwise update this Privacy Policy at any time and in case of changes and amendments to the legislation. The User consents to such changes, amendments or updates.

The Company shall notify you of changes by posting an updated version on this page and indicating the date of the changes. By continuing to use the maag-fashion.com Website (including access, browsing and/or use of any interactive features), the User shall agree to this Privacy Policy and any changes hereto. The Company recommends you to read this Privacy Policy from time to time to learn how the Users' Personal Data is protected.

- 5.4.1.
